The Director of Mineral and Energy Economy Research Institute, Polish Academy of Sciences in Kraków announces a competition for the post of assistant professor for research in the field of mercury removal technology from flue gases and research on solid sorbents in the DIVISION OF APPLIED GEOCHEMISTRY AND ENVIRONMENTAL ENGINEERING.

Candidates should meet the conditions set out in Article 89, paragraph 3. of the PAS Act of 30 April 2010, as amended.

Requirements:

- possession of a doctoral degree in engineering and technology field, in the discipline of chemical engineering,
- authorship or co-authorship of published, peer-reviewed scientific papers,
- a certificate of proficiency in English or another congress language (German, French, Spanish, Russian, Italian) at a level of at least B2,
- demonstrated aptitude for scientific work (experience and engagement in research projects related to the subject of the competition, confirmed by a professional reference from the current supervisor).

An additional advantage will be:

- proven scientific output (list of publications) in the form of articles in international or national scientific journals and in the form of conference presentations,
- a minimum of two years' experience working on mercury sorption test installations,
- experience in scientific and research work,
- experience in managing research projects,
- participation in research fellowships and traineeships.

1. Application for employment addressed to the Director of the Institute together with a signed information clause (Annex 1).
2. CV.
3. A copy of a diploma obtaining a doctoral degree in the field of engineering and technical sciences in the discipline of chemical engineering.
4. Certificate confirming knowledge of the foreign language listed in the requirements.
5. Inventory of published and ongoing work and projects.
6. Professional reference from the current supervisor, confirming achievements and engagement in projects related to the subject of the competition.
7. Declaration that the Institute of GSMiE PAN is the primary place of work (in case of winning the competition).
8. Statement of acceptance of the terms and conditions of the competition.
